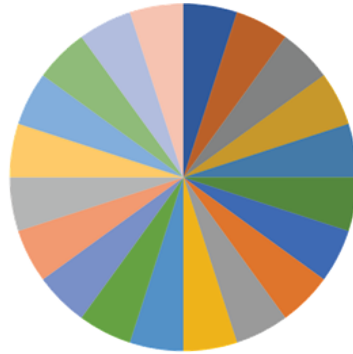
### Bonus Draw

3 Lucky Winners will be invited to the stage participate to the Lucky Spin.

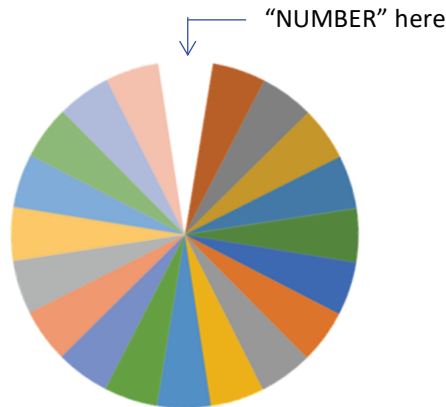

### Consolation Prize
